In 2006, 13-year-old Megan Taylor Meier took her own life following a cruel cyberbullying hoax by an adult neighbor posing as a fictitious boy on MySpace. The Megan Meier Foundation was created to help prevent this from happening to others.

Each year, 13 million children like Megan are negatively affected by bullying and cyberbullying. The suicide rate of youth aged 10-24 has increased by 56% in the past 10 years. The Megan Meier Foundation provides vital programs that support struggling youth including educational presentations, leadership workshops, and counseling services serving over 611,000 people since its creation.



Play Fore! Megan is the organization's annual golf tournament and largest annual fundraising event. Support of the golf tournament allows the foundation to continue to serve the youth that need us the most and count on us to be there!


